- Urgent Care → \$ 15 copay
- Physical Therapy* → \$ 0 copay

► What is a deductible? _____

The dollar amount you must pay toward qualified medical and pharmacy expenses before coverage by the Plan will begin.

► What is "deductible waived"? _____

The Plan will waive the deductible requirement and cover specific services and medications at 100%.

► What is the most I will have to pay in a plan year if I get really sick? _____

Including the deductible and copays, you will not pay more than \$6,000 on the Individual Plan or \$12,000 on the Family Plan during a Plan Year.

► A high-deductible health plan is a big risk. How can I prepare for unexpected situations? _____

Share Select is an HSA eligible high-deductible health plan. You can take advantage of this personal savings account option which allows you to save and pay for qualified health-related expenses all on a pre-tax basis.
